

- Community Land Trusts (CLTs) are set up and run by ordinary people to develop and manage homes as well as other assets important to their community, like community enterprises, food growing or workspaces. CLTs act as long-term stewards of housing, ensuring that it remains genuinely affordable, based on what people actually earn in their area, not just for now but for every future occupier.
- Craven Community Land Trust (CCLT) has very specific Rules that can be seen in our Financial Conduct Authority Registration Document. These are the principles that all members sign up to. Anybody over the age of 16yrs can be a member.
- Our primary aim is to ensure that there is sufficient housing in the Craven area for single people and couples to rent securely, particularly for those people on lower incomes. These homes will be for people living, working, or having close family ties with the area. There will be a strict allocations policy, overseen by the Board. Please note that members are not automatically eligible for tenancy.
- Future projects could involve taking on other assets that are important to the wellbeing and resilience of the community.
- As far as possible all homes and other assets will be as well constructed and energy efficient as possible.
- All property owned by the CCLT, will be asset locked. This means there will be no sub-letting, no shared ownership schemes and no right to buy. The properties will be owned and administered by the CCLT strictly within the rules of the CCLT.
